#### **2022 MEETING MINUTES**

The 76th annual meeting of Slope Electric Cooperative, Inc. was called into session at 6:03 p.m. by President Steven Wegner at the Slope County Fairgrounds in Amidon, North Dakota on June 2, 2022, with 95 registered members present. Wegner announced that Robert's Rules of Order would be followed.

Director Carlson confirmed the notice of meeting and proof of mailing of the last annual meeting as it is printed in the annual report. The membership voted to dispense with reading the notice and minutes, and accepted the minutes as presented.

The next order of business was the nomination and election of directors. Trevor Steeke, spokesperson for the nominating/resolutions committee, submitted the following nominations: Adams County – Anthony Larson, and Bowman County – Jerome Caron and Chip Fischer. No nominations were received by petition or from the floor. A motion was made to suspend the rules and have the secretary cast a unanimous ballot for the directors nominated by the Nominating Committee.

The next item of business would be to consider amendments to the Cooperative's Bylaws. These were provided to the membership in their entirety as part of the annual meeting packet. A motion was made, seconded and carried to dispense with the requirement of reading the Amended Bylaws in their entirety, and then a motion was made, seconded and unanimously carried to approve the Amended Bylaws in their entirety.

Co-General Manager Travis Kupper presented the Co-General Managers/CEO report to the membership. He noted that this was Co-Manager Don Franklund's last annual meeting, as Mr. Franklund announced his retirement. He thanked Mr. Franklund for his dedicated service to the Cooperative. Mr. Kupper discussed how this year's annual meeting theme mirrored how the Cooperative was established. He presented a video from Member Service Manager Brooke Waltner which illustrates the Cooperative's activities in its service territory. A video of Operations Manager Dean Volk was shared with the membership, in which he outlined the actions being taken by the Cooperative to provide advanced, reliable service to the members.

CFO Alex Craigmile presented the 2021 Slope financial report as contained in the annual meeting notice, which was accepted by the membership.

Operation Round Up Director Laurie Braaten gave the Operation Round Up Report. In 2021, Operation Round Up made over \$9,600 in donations to two individuals and 8 different organizations.

A Slope employee and director earned service awards for their tenure with the Cooperative: Mark Frank – Line Technician (10 years), and Lauren Klewin – Director (25 years).

Slope offered two "Luck of the Draw" scholarships to senior students whose parent(s)/guardian(s) are members of the Cooperative and in attendance at the annual meeting, and the winners were Chevy Dhamers and Madison Wilson. Also announced was the Youth Tour Winner for this year, Caleb Sarsland, from Bowman County High School.

There being no additional business, a motion was made, seconded, and carried to adjourn the meeting. The meeting was adjourned at 7:01 p.m.

#### **VOTING GUIDELINES**

Voting regulations are part of the bylaws of Slope Electric Cooperative, Inc. The spouse of a member automatically holds a proxy if the member is not present. No paperwork is required for spouses who wish to vote in place of the absent member.

#### **BYLAWS ARTICLE III, SECTION 5**

Each member shall be entitled to only one vote. All questions shall be decided by a vote of a majority of the members voting thereon in person, except as otherwise provided by law, the articles of incorporation, or these bylaws. Corporations, cooperatives, firms and bodies politic shall have the right to cast one (1) vote on any issue the same as other members, provided that a duly elected and acting officer executes a proper certification or other qualifying instrument as the Board of Directors may, from time to time, prescribe.

#### **BYLAWS ARTICLE III, SECTION 7**

Voting by proxy shall not be allowed except that the spouse of a member who is not present and registered shall be considered to hold a proxy of that member and shall be entitled to vote.

# PROPOSED SLOPE ELECTRIC COOPERATIVE, INC. BYLAW AMENDMENTS

#### AMENDMENT 1

Article I, Section 3 (b) The vote of either separately, or both jointly, shall constitute one joint vote, but should both be present, but in disagreement on such vote, each shall cast only one-half (1/2) vote.

#### **AMENDMENT 2**

Article III, Section 1 The annual meeting of the members shall be held between during the month of May or June May 1 and August 31 each year at a date to be determined by the directors...

#### **AMENDMENT 3**

Article IV, Section 4 ...The committee, keeping in mind the principle of geographical representation, shall prepare and post at the principle office of the cooperative at least forty-five days before the meeting a list of nominations for the directors, but any fifteen or more members, acting together, may make other nominations by petition not less than sixty ninety days prior to the meeting, and the secretary shall post such nominations at the same place where the list of nominations made by committee is posted.

#### PLANNING TO BUILD OR UPGRADE?

Whether you are looking to build a new structure or make changes to an existing structure, it is important to contact Slope Electric Cooperative in the early planning stages.

Each year Slope Electric helps members with their construction upgrades and new builds. Projects can range from pasture wells to grain storage, new outbuildings, houses and businesses. For projects of all sizes, it is important to contact your local cooperative. By doing so, you will be able to confirm the viability of your project. Slope Electric's engineering department can verify whether we can serve additional load in your area and the availability and cost of equipment and materials.

Information that you will need to share with the cooperative include the type of upgrade or new build, location, timeline and power requirements.

#### Follow these tips to achieve energy efficiency:

- Location matters. If possible, carefully consider where you build your shop or barn.
   Consider drainage, sun exposure and how the building may affect your neighbors.
- Start with a sustainable design plan. A sustainable design plan, according to the U.S.
  General Services Administration, includes the ability to use environmentally preferable
  products; protect and conserve water; enhance indoor environmental quality; and
  optimize operational and maintenance practices.
- Choose efficient building methods. Pole barns offer reliable shelter without costly excavation, concrete foundations or general site disruption.

Operation Round Up is a program of voluntary contributions through rounding up electric bills to the next dollar.






#### WHERE YOUR DOLLAR CAME FROM 2022

#### **SLOPE ANNOUNCES YOUTH TOUR WINNERS**

For many teens, the Rural Electric Youth Tour is full of "firsts." It may be the first time they left the state, flew on a plane, visited the nation's capital or have been away from their family for an extended period of time. Even more are seeing and experiencing the larger world through their own eyes, rather than through their parents' perspective. Youth Tour sprang from a suggestion of then Senator Lyndon Johnson to a national gathering of co-ops. Johnson felt youth from rural areas would benefit by visiting Washington to see first-hand how government works and gain a wider perspective through the experience. From this idea, Youth Tour evolved. High school juniors selected by their electric co-ops participate in a weeklong trip to the nation's capital. The program has grown exponentially since its inception and this year, we saw more than 1,800 high school juniors participate from co-ops in 44 states.

North Dakota alone sends a delegation of 13 students. These students are selected by their cooperative and chosen through an essay writing contest. This years question, "What moment in American history do you wish you had been a part of and what would you have contributed?

Through this contest, Slope Electric has selected two winners: Julie Sarsland from Rhame, ND, and Julia Dalley from Hettinger, ND.


